Abhishek Shaw

(6th Year, Economics)

Abhishek's paper "Food supply chains and resilience to shocks: Evidence from India's COVID-19 lockdown" co-authored with Nikita Gupta and Prof. Vidya Vemireddy was published in Applied Economics Perspectives and Policy on April 11, 2023. Abhishek also presented his paper titled, "Affirmative Action in Higher Education: Understanding OBC Reservations in India" at the 18th Annual Conference on Economic Growth and Development organised by Indian Statistical Institute Delhi Centre, New Delhi between December 18-20, 2023.

Nirved Kumar

(5th Year, Innovation and Management in Education)

Nirved was selected for the Research for Impact (RFI) Fellowship offered by CLEAR/J-PAL South Asia at IFMR during 2022-2023. The RFI fellowship awarded him a scholarship to complete the MITx MicroMasters course, following which he worked on an ongoing JPAL South Asia project evaluating the impact of Health and Wellness Center reforms in Rajasthan. Nirved won the best proposal award for his thesis proposal titled "Exploring sociopolitical development among youth policy workers: Role and influence of fellowship programs" at the 4th Doctoral Colloquium on Management and Development, organized by the Institute of Rural Management (IRMA).

Pallavi Rachel George (4th Year, Public Systems)

Pallavi has been awarded the Fulbright-Kalam Climate Fellowship for Doctoral Research by the United States-India Educational Foundation. Funded by the governments of the United States and India, the Fulbright-Kalam scholarship is awarded to doctoral students working on climate changerelated issues to support a 6-9 month visiting student researcher (VSR) position at a host institution in the United States. Pallavi will be researching urban coastal resilience planning and policy at the Massachusetts Institute of Technology (MIT), in Cambridge, MA for nine months, starting August, 2024.

Praharshita Krishna

(6th Year, Information Systems)

Praharshita participated (online) in the PAN IIMA Conference 2023 organised by IIM Sambalpur between January 23-27, 2024. She presented her paper titled, "Codefluencers Talk Easy, Work Steady: An Analytical Understanding of Predictors of Developer Popularity and Sponsorship on Social Coding Platforms" co-authored with Prof. Adrija Majumdar and Prof. Indranil Bose and was awarded the Best Paper Award for her presentation.



Pramendra Singh Tank (4th Year, Strategy)

Pramendra's paper "Unbundling Accelerators' Design: Impact of Accelerators' Characteristics on Venture Performance," won Runner-up prize at the inaugural India Strategy Conference (2023) organsied by IIM Ahmedabad, IIM Bangalore, and Indian Schools of Business. His paper "Do Firms Respond to Commitments on Climate Change? Impact of COP21 on Investment Intensity," was recognized as the Best Submission in the ESG and Non-Market Strategy Track. He won the Best Doctoral Student prize at the conference. Pramendra participated in the Indian Academy of Management (INDAM) Conference at Goa Institute of Management, and won Best Paper (Runner-up) for his paper titled "Leading to Innovate: Exploring the Link between a Leader's Promotion Focus and Firm Innovation Performance," co-authored with Prof. Amit Karna. He presented this paper also at Asia Pacific Innovation Conference (APIC) at Ahmedabad University.

Pramendra participated in the International Conference on Digital Organization (ICODO) at Ahmedabad University and presented a paper titled "Striking the Balance: The Impact of Digital Investment on Environmental and Social Performance."

Pranusha Kulkarni (7th Year, Public Systems)

Pranusha secured funding through two fellowships: the Research and Writing Fellowship at IIT Kanpur's Just Transition Research Centre for empirical research at Pavagada solar park, Karnataka, and the India Tech Policy Fellowship by Pacific Forum to study India's semiconductor supply chains. She was also invited to teach "Just Sustainability Transitions" at NLSIU, Bengaluru, and presented a co-authored paper on Karnataka's energy transition policy at the Empowering Futures Summer School by IIHS and international universities from March 27-29, 2024, focused on sustainable energy transitions in the Global South.
