## Urban – Rural Income Differential in Major States: Contribution of Structural Factors

### ABSTRACT

In this paper, we have attempted to estimate the urban – rural income differential (URID) for 15 major states based on readily available data on GSDP by sectors, population and employment by sectors and urban – rural residence. There are three components of the URID, viz., worker population ratios (WPR), employment structure and labor productivity by sectors in urban and rural areas. We are unable to estimate the labor productivity differentials at the state level, but the other two factors are considered and the floor estimate for the URID is obtained for the 15 states in the four base years. Moreover, it is also shown with the help of the estimates available at the All India level that out of the three factors, employment structure is the most dominant one to determine URID and that the component of productivity differential is not very high. Assuming the same extent of the component of productivity differential for each state as for the country, estimates of the URID in the major states for the three base years are derived. We have also attempted an estimate of the URID for the country and the states in the likely base year of 2011-12 with corresponding urban and rural per capita incomes.

## Urban – Rural Income Differential in Major States: Contribution of Structural Factors

### I. Introduction

Income inequality existing between urban and rural areas is an important feature of the development of an economy. Very often people refer to it for reflecting on the differences in the average standard of life between the two areas. Ideally for this purpose we need estimates of the personal income in the two areas, which are simply not available in the country given the regional accounting framework and problems associated with cross border flows of goods and services. It is, therefore, very popular to use consumption expenditures by households as a proxy for the personal income to reflect upon the differences in living standards. It obviously ignores the differences in the saving behavior of population in the two areas. Income originating within the geographical boundaries given by the concept of ‘domestic product’ can serve as an alternative, particularly because it captures physical developments, employment level and productive potential of the area. In this context, it becomes extremely relevant to generate estimates of urban and rural domestic products in an economy.

At the national level, Chakravarty et al (1960) and Rao (1965) recognized this need and attempted their own estimates of the urban and rural incomes respectively for the years 1952-53 and 1950-51 and 1960-61. The Central Statistical Organization (CSO) then started producing these estimates for the country as a whole in different base years for the national income series. Thus, it has prepared and published estimates of the urban and rural domestic products for the years 1970-71, 1980-81, 1993-94, 1999-00, and 2004-05 (CSO, 1979, 1988, 1999, 2006 and 2010). Since the proposed new base year for the national income series is 2011-12, we can expect the next estimate of urban and rural domestic product for that year brought out around 2015-16. It is, however, surprising that a similar effort is not made at the state level in spite of the Committee on Regional Account clearly recommending it in its final report as long back as 1976. The only effort to prepare estimates of the urban-rural income differentials for major states in the country was by Dholakia and Dholakia (1978) for the year 1970-71.

Subsequently, the National Statistical Commission (2001) also recommended the same thing and asked the CSO to standardize the methodology and prescribe broad sources

for preparation of the estimates of urban and rural domestic product at the state level. Accordingly, the CSO (2008) has prepared detailed guidelines for the states for the purpose. For several sectors and sub-sectors, the CSO and NSSO provide the estimates of domestic product by urban – rural areas upon official requests from the respective states. However, there are hardly any estimates of the urban and rural domestic products prepared at the state level barring a few exceptions (e.g., Dholakia and Pandya, 2012 for Gujarat). As a result, we do not have any idea about the variation in the urban – rural income differential across states in the country and its behavior over time. This important dimension of economic development and useful planning and evaluation input not only for the government agencies but also for the private sector businesses, therefore, remains unaddressed and unused.

One possible reason for this state of affairs is that CSO and NSSO do not provide the estimates for some sectors and sub-sectors that they provide to the respective states to individual scholars or even to other state statistical bureaus. In the present paper, therefore, we make use of whatever data in this regard available readily in a comparable and analytically usable form. Gross State Domestic Product by broad sectors and employment by broad sectors for major states are readily available from published sources. We, therefore, attempt to investigate the effects of differing structure of working force in the urban and rural areas on the income differential in 15 major state economies in the country. We have attempted the exercise for four recent base years – 1993-94, 1999-00, 2004-05 and 2011-12 to examine the trend in this ratio in different states. The framework used for estimation and data sources are briefly described in the next section. Section III estimates the effect of Worker Population Ratio on the income differential. Section IV then estimates the effect of the differing structure of employment in the two areas on the overall productivity and income differential. Section V attempts estimates of urban and rural incomes in the states in the four base years by assuming the same extent of the productivity differentials as at the national level. The final section concludes the paper.

## **II. Method and Sources of Data**

Our purpose is to estimate total Urban Income (UI) and Rural Income (RI) and obtain per capita income in both the areas to get the differential in a given year. We can, therefore, represent the Urban – Rural Income Differential (URID) as –

$$\text{URID} = (\text{UI}/\text{UP}) / (\text{RI}/\text{RP}) = (\text{UW}/\text{UP})(\text{UI}/\text{UW}) / (\text{RW}/\text{RP})(\text{RI}/\text{RW})$$

Where UP and RP represent respectively urban and rural population; UWPR and RWPR represent respectively urban and rural worker population ratio; and ULP and RLP represent respectively overall urban and rural labor productivity. If the overall urban and rural labor productivity is assumed to be the same as for the whole economy, URID would be given by the ratio of UWPR and RWPR.

In order to get overall labor productivity differential between urban and rural areas, we can consider the following equation –

Where  $UI_i$  and  $RI_i$  are respectively the urban and rural income originating in the  $i$ th sector; and  $UW_i$  and  $RW_i$  are respectively the urban and rural workers employed in the  $i$ th sector. Therefore, the labor productivity in  $i$ th sector is given by  $UI_i/UW_i$  in the urban area and  $RI_i/RW_i$  in the rural area. Similarly, the structure of employment in urban and rural areas is represented respectively by  $UW_i/UW$  and  $RW_i/RW$ .

Now, by replacing equation (2) in equation (1), we get the expression of URID in terms of its basic determinants, viz., UWPR, RWPR,  $UW_i/UW$ ,  $RW_i/RW$ ,  $UI_i/UW_i$  and  $RI_i/RW_i$  –

$$\text{URID} = (\text{UWPR}/\text{RWPR}) * [(\sum (\text{UI}_i/\text{UW}_i) * (\text{UW}_i/\text{UW})) / (\sum (\text{RI}_i/\text{RW}_i) * (\text{RW}_i/\text{RW}))] \dots \dots (3)$$

Out of these six determinants of URID, we can readily get the estimates of the first four, i.e. worker population ratios in the two areas and structure of the work force in the two areas. What we do not get readily are the estimates of the sectoral productivities of workers in the two areas. However, we have firm estimates of the sectoral productivities of workers in the economy as a whole from the estimates of GSDP and employment in the economy. If we assume that the productivity per worker at the sector level remains the same in the urban and rural areas in the face of non-availability of such information in the published form, we can estimate the urban – rural income differential existing on account of the structural factors at the state level. By and large, it would represent a lower limit on the true URID at the state level, because sectoral labor productivities in the urban areas are most likely to be higher than in the rural areas in most of the sectors.

In this context, it is worth noting that the CSO (2008) methodology suggested for estimating the urban and rural income at the state level recommends allocation of the domestic product to urban and rural areas based on the employment in several sectors and sub-sectors. Dholakia and Pandya (2012) found while applying the same methodology to Gujarat state that almost 52% of the total GSDP in 1993-94 was allocated in this way. This proportion goes on falling over time because of: (i) shifting share of income from such sectors; and (ii) more data sources available progressively for newer base years. Thus, our method of considering structural factors to estimate URID provides a good starting point and a floor estimate particularly when urban – rural sectoral labor productivity differentials are not available.

We expect considerable difference between the employment structures of urban and rural areas depending on the level and pattern of economic development in the economy. Usually, in the initial stages of economic development, the employment structure in the two areas would sharply differ because agricultural and other low productivity activities would dominate in rural areas, but secondary and tertiary high productivity activities would dominate and get concentrated in urban areas. The difference between the employment structures in the two areas would keep increasing over time till the economic development also trickles down and start impacting agriculture and value additions in rural areas. Once such a level of development is reached, differences between urban and rural areas get blurred and their employment patterns start converging. In order to capture this aspect across states in India, we need a measure of structural difference between two areas. Coefficient of Structural Difference (CSD), suggested by Dholakia (1985) can serve the purpose. It is given by ---

$$\text{CSD} = [\{\sum (X_i - Y_i)^2\}/(n - 1)]^{1/2} \dots \dots \dots \quad (4)$$

Where  $X_i = UW_i/UW$  and  $Y_i = RW_i/RW$ ;  $\sum$  represents sum over all sectors; and  $n =$  number of sectors. CSD would always lie between 0 and 1.42. Higher is the value of CSD, larger is the difference between the structures of employment in the two regions. The same measure can also be used to measure the structural difference in employment in a state from the national average in urban and rural area separately.

The data used in this exercise are taken from the following sources:

- 1 NSS Results for 43rd(1993-94) , 50th(1999-00), 55th(2004-05), and 63rd(2011-12) Rounds, NSSO, MoSPI, Government of India.

- 2 National Account Statistics, 1993-94, 1999-00, 2004-05, Central Statistics Office, MoSPI, Government of India.
- 3 Population Censuses 1991, 2001, 2011, Registrar General of India, Government of India.
- 4 State Domestic Product Series for the years 1993-94, 1999-00, 2004-05 and 2011-12, MoSPI website, Government of India.

There are some adjustments necessary to make the data updated and analytically usable. These adjustments are for the population of urban and rural areas in the states for all the years under consideration. These adjustments would affect the number of workers because it is derived by applying the estimates of the parameters like WPR to population and then employment proportions in different sectors to so derived number of workers. Usually the estimates of population by area are provided by MoSPI, GoI by extrapolating the Census population figures. These estimates can change substantially for urban and rural areas once actual Census population is available. We have, therefore, made these adjustments in the population figures based on actual inter-census interpolation (Appendix Table 1). Moreover, we have considered the 15 major states of India for our study. We are constrained to consider only 9 one digit broad sectors in both urban and rural areas because NSS surveys on Employment and Unemployment provide data on workers only by those 9 sectors.

### **III. Effect of Worker Population Ratio (WPR)**

Table 1 provides estimates of the WPR in urban and rural areas of the major states in the four base years. As expected, it shows that in each year, WPR in urban area is substantially less than the one in the rural area in all states except in West Bengal. Over the last twenty years, although no clear trend emerges in the movement of WPR in urban areas in most states, in Gujarat and Punjab it is rising and in Kerala it is marginally falling. Similarly, the movements in rural WPR also do not show any clear trend in states, but in Andhra Pradesh, Bihar and Madhya Pradesh, it is declining over time.

In order to get the contribution of WPR in determining the urban – rural income differential (URID), we need to take the ratio of (UWPR/RWPR) for each of the four years. Table 2 presents these ratios for the four base years. The table presents the URID when only WPR is allowed to change between urban and rural areas as observed in the four base years. It can be observed that URID would have been substantially less than one in all states and the country except in West Bengal. The overall trend in the ratio of the urban and rural WPR over the last twenty years shows that the WPR in the two areas are consistently coming closer to each other or converging. Thus, if productivity differential between the two areas remain constant over time, the URID would show an increasing trend over time. This trend is consistent over time in Bihar, Gujarat, Maharashtra, Tamil Nadu, Uttar Pradesh, Madhya Pradesh, Rajasthan, West Bengal and at all India level. It is clear that in all these states and the nation as a whole, changes in WPR would be driving the URID up and overall productivity differentials would have to show a balancing declining trend to keep the URID from rising over time. Thus, if targeted programs aimed specifically at increasing rural labor productivity in different sectors are not implemented, the URID will show tendency to increase in future.

#### IV. Effect of Differing Structure or Employment

After adjusting population by urban and rural areas in each state by interpolating the census population figures, corresponding WPR estimates obtained from the NSSO reports are applied to get the total workers in the two areas. The sector-wise break-up of the work force in the two areas is then obtained by applying the composition given in NSSO reports (Appendix Table 2). Thus, the structure of the work force in both the areas individually is essentially the same as given in the NSSO reports. It is the structure of the work force in the economy as a whole that would change because of possible differences in the urban – rural population estimates. This would affect the sectoral productivity of workers in the economy as a whole because the GSDP estimates would remain the same but the estimates of workers would change.

It would be interesting to see the extent of variation in the employment structure in the major states from the average for the nation. We measure this by the Coefficient of Structural Difference (CSD) discussed in section II above. Table 3 presents CSD for major states in all the four base years in the urban areas, and Table 4 for the rural areas.

From Table 3, it can be seen that the employment pattern within urban areas does not differ substantially in states from the corresponding national average in all the four base years. The maximum difference is observed in Assam in all the four years and it is declining over time. In 2011-12, the urban areas in Gujarat, Orissa and Bihar besides Assam show the structural difference in employment pattern above 0.05. In 1993-94, only two states – Assam and Kerala had the difference above 0.05. Thus, over last twenty years, the employment pattern in urban areas of the states has shown marginal divergence with a few states experiencing major changes.

Table 4 shows that the employment pattern within the rural areas of the major states is even closer to the national average in all the four years than observed for the urban areas in Table 3. Employment pattern in the rural areas of Kerala was substantially different from the national average in 1993-94 and the difference kept increasing over the last twenty years. The difference in the urban areas of Kerala on the other hand was fluctuating but overall declining over time. Thus, it is the rural area in Kerala that experienced substantial changes in the employment pattern compared to the nation. West Bengal is the only other state where employment pattern in the rural areas has been substantially different from the national average. However, the trend therein is overall such that it is coming closer to the national

average over time. Thus, West Bengal shows relative stagnancy in its employment pattern, whereas Kerala reveals relatively greater vibrancy in its employment pattern in the rural areas.

In order to find out whether employment pattern in a state differs more from the national average in the urban area or rural area, we can take the difference between the Urban CSD (Table 3) and the Rural CSD (Table 4). This is presented in Table 5. Positive sign of the difference shows that the structural difference in the urban area of the state is more than in the rural area. Negative sign would show the opposite. The Table 5 shows a very interesting characteristic of the development in the country over the last twenty years. Its major state economies show a clear pattern of changes in employment structure more concentrated either in urban areas or in rural areas throughout the last twenty years. Very few states show fluctuating trend. Thus, Andhra Pradesh, Bihar, Gujarat, Uttar Pradesh, Assam and Orissa

show greater structural difference from the national average in the urban areas than in their rural areas. On the other hand, Karnataka, Maharashtra, Tamil Nadu, Kerala, Madhya Pradesh, West Bengal and Haryana display higher structural difference from the national average in their rural areas than in the urban areas. Thus, the structural changes in the work force at the national level in the urban and rural areas are driven respectively by these two groups of states.

We may now turn to examining the structural difference between the urban and rural employment patterns in the major states with the help of CSD in each of the four base years. Table 6 presents the results. It can be seen from the table that the employment structure of the urban and rural economies in all states, except Kerala, differ substantially in all the four base years. In 1993-94, the CSD between urban and rural areas was more than 0.24 in all states except Kerala, Tamil Nadu and West Bengal. The highest CSD was found in Assam followed by Madhya Pradesh in 1993-94. During the last twenty years there have been substantial

changes in the employment structure in the state economies. In 2011-12, CSD in Kerala is less than 0.1 and in Tamil Nadu, Punjab and Orissa it is less than 0.2. West Bengal and Haryana are also very close to 0.2. In several major economies, the structure of employment in the two areas is moving closer or is converging, but in two major economies of Gujarat and Maharashtra, the structural difference between urban and rural areas has remained almost constant over time. Now, both these are emerging as the states with highest structural differences between the two areas. It is not that the employment pattern in these economies has remained stagnant over time, but the changes in them have been of similar dimension in both the areas.

Now, we can consider the estimates of the URID based on the assumption of equal productivity per worker in urban and rural areas within each of the sectors considered. Details of the calculations of labor productivity by sectors in all areas are given in Appendix Table 3; and urban and rural incomes by the broad 9 sectors are given in Appendix Table 4 based on equal labor productivity assumption. Here we consider only the final outcome in terms of URID for the four base years in Table 7.

Table 7 shows what we call the floor estimates for the URID in major state economies in India over the last twenty years. Kerala and Punjab show the minimum URID over the period. The urban per capita income in these two states is not even 20% higher than the rural per capita income on account of only the structural factors. This indicates that the rural and urban areas in these two states are not very different from each other. The worker productivity, therefore, may also not be substantially higher in urban areas than the rural areas leading to the expectation that the true URID may not be very high in these two states. However, in the remaining states, the URID on account of the structural factors alone is substantial and is likely to be higher in practice with productivity differential in favor of urban areas. Table 7 also shows that the absolute contribution of the structural factors to the URID has a declining trend from 1999-00 to 2011-12 in Bihar, Gujarat, Tamil Nadu, Kerala, Madhya Pradesh, Punjab, and West Bengal. In the remaining states, the differential shows fluctuating trend.

It is possible for us to take the contribution of the WPRs out from the URID derived in Table 7 on the assumption of same productivity of urban and rural workers in different sectors. This would give us the contribution of the pure employment structure on the urban – rural per capita income differential. This can be achieved by deflating the estimates in Table 7 by the ones in Table 2 above cell by cell. Table 8 presents these estimates.

Table 8 shows that the effect of employment structure on the urban – rural income differential is very high in 11 out of the 15 major state economies in the country. Only in Kerala, Punjab, Haryana and West Bengal the employment structure per se leads to the URID of less than 2. In order to see the relative contribution of the three broad factors, viz., Worker rate, employment structure and labor productivity difference, we need to consider the estimates at the all India level, because we do have proper estimate of URID with all factors included. At the aggregate level, URID for the base years 1993-94, 1999-00 and 2004-05 are available as noted earlier. They are respectively 2.3388, 2.8253 and 2.6912. For the likely base year 2011-12, the estimates are yet not available for the country. Since our framework is multiplicative, we can consider the figures from our Tables 2, 7 and 8 together with these three estimates of URID for All India to get importance of individual factors. The labor productivity differential between the urban and rural areas works out to be 1.2242 in 1993-94; 1.3647 in 1999-00; and 1.2504 in 2004-05. As compared to this, the component of WPR works out to 0.7815 in 1993-94; 0.8082 in 1999-00; and 0.8314 in 2004-05. Similarly, the component of employment structure works out to 2.4444 in 1993-94; 2.5616 in 1999-00; and 2.5886 in 2004-05.

Thus, the employment structural factors appear to be very dominant in relation to other two factors in determining URID. Similarly, the labor productivity differential as a factor does not appear to play a very substantial role in determining the URID at the

aggregate level. It could be relatively more important in some states, but it seems unlikely that it would be a dominant factor in any state given the figures in Table 8 above.

Finally, based on our analysis above, we can predict the URID at All India level in the year 2011-12. Out of the three components, we already have two. WPR component is 0.8897, employment structure component is 2.3307 and the labor productivity component could be taken the same as in 2004-05, i.e. 1.2504. This would result in 2.5929 of URID in 2011-12, implying that urban per capita income would be Rs. 118,750 and rural per capita income would be Rs. 45,798 at the current prices.

## **V. Our estimates of Urban and Rural Incomes by States**

We may now attempt estimates of per capita incomes (GSDP) in urban and rural areas of the major states in India. Table 7 provides combined effect of WPR and employment structure on the URID, because it is derived on the assumption of the same labor productivity by sectors in urban and rural areas. As shown above, at the national level the contribution of the productivity differential is not very substantial in all the three latest base years for which the national estimate of URID is readily available. We may, therefore, take the component of productivity differential to remain the same across state as at the national level for the given year to derive the estimate of URID at state level. We may also derive our estimates of the URID for the 15 major states for the year 2011-12 by assuming the productivity differential component at the same level as observed for the nation in the year 2004-05. These estimates of URID so derived for all the four base years are presented in Table 9.

Based on these estimates of URID, we can derive the estimates of the urban and rural per capita domestic products for the four base years using the estimates of the per capita GSDP for the states for the respective years available from the CSO website. The method to derive these estimates can be described as follows—

$$\text{PCI} = (\text{UP}/\text{TP})(\text{UI}/\text{UP}) + (\text{RP}/\text{TP})(\text{RI}/\text{RP}) \quad \dots \quad (5)$$

Where PCI is per capita GSDP; UP, RP and TP are respectively urban, rural and total population; and UI and RI are respectively urban and rural population.

Since  $URID = (UI/UP) / (RI/RP) \Rightarrow (UI/UP) = URID \cdot (RI/RP)$  ..... (6)

Replacing Eq. (6) in Eq. (5), we get

$(RI/RP) = PCI / [URID (UP/TP) + (RP/TP)]$  and then  $UI/UP = URID (RI/RP)$ .

Table 10 presents our estimates of the urban and rural per capita incomes at current prices for the four base years. These estimates show that rankings of states according to per capita incomes undergo substantial changes from the rural economies to urban economies, particularly for the better performing states like Maharashtra, Tamil Nadu, Gujarat, Punjab, and Kerala. It helps to identify relatively weaker points in the development strategy of states. The table also shows that the inequality or disparity between the richest and the poorest states is about 4 times in rural incomes and only 3 times in urban incomes. Thus, with greater urbanization, regional disparity would tend to decline.

## VI. Concluding Remarks

Estimates of urban and rural incomes at the state level are required not only to complete the regional accounts, but also to lend support to various developmental efforts undertaken by the government and private sector entities by properly evaluating and monitoring long term programs. They would also help in cross-checking and verifying several estimates generated out of national level surveys, quality of allocations of income and several other aggregates regularly and routinely carried out by the CSO to state bureaus, and internal consistency of several ratios, proportions and methods used by state bureaus for preparing regional accounts related aggregates. As we have shown in the paper, the sectoral productivity differentials are not likely to be overwhelmingly substantial for determining the urban – rural income differential (URID) in India. Hence we have derived the estimates of urban and rural income based on the productivity differential component of URID remaining the same for different states as at the national level for a given year. Very interesting patterns emerge from our estimates of separate rural and urban per capita incomes, proving the utility of such estimates for development strategy, planning and policies at the state level. If the Statistical Commission directs states to prepare such estimates and if CSO becomes more transparent in sharing data, it will serve a good cause.
